The vehicle will be available for inspection at the FSC House on normal working days, as from Monday 02<sup>nd</sup> September 2024 to Friday 06<sup>th</sup> September 2024, from 10:00 hrs. to 15:00 hrs. The Administration and Enterprise Risk department may be contacted on 403-7000 for any additional information.
- (c) Tender should be made on prescribed forms which may be obtained at the reception desk located at the FSC House or downloaded from the FSC Website on the following link: http://www.fscmauritius.org.
- (d) Tender in sealed envelope should be clearly marked 'Tender for Sale of Vehicle' on the right-hand corner and addressed to:

The envelope should be deposited in the Tender Box D located at the ground floor at the FSC House, not later than 15:00 hrs on Friday, 13<sup>th</sup> September 2024.

- (e) The deed of the sale and any other relevant documents will be drawn in the name of the bidder or as otherwise agreed by the bidder. It is therefore advisable that bidders, while quoting for the vehicle take into account the amount of registration duty payable thereon.
- (f) Tender must be accompanied by an office cheque representing 5% of the tender value as bid security which will be realised and enforced immediately upon acceptance of the offer by the FSC. The amount thereof will be forfeited if the purchase is not finalized within five working days of acceptance.

- 4. Tender should be addressed to the Manager- Administration and Enterprise Risk and deposited in the tender box located at the Financial Services Commission, FSC House, 54, Cybercity, Ebene not later than 15:00 hrs on Friday, 13<sup>th</sup> September 2024.
